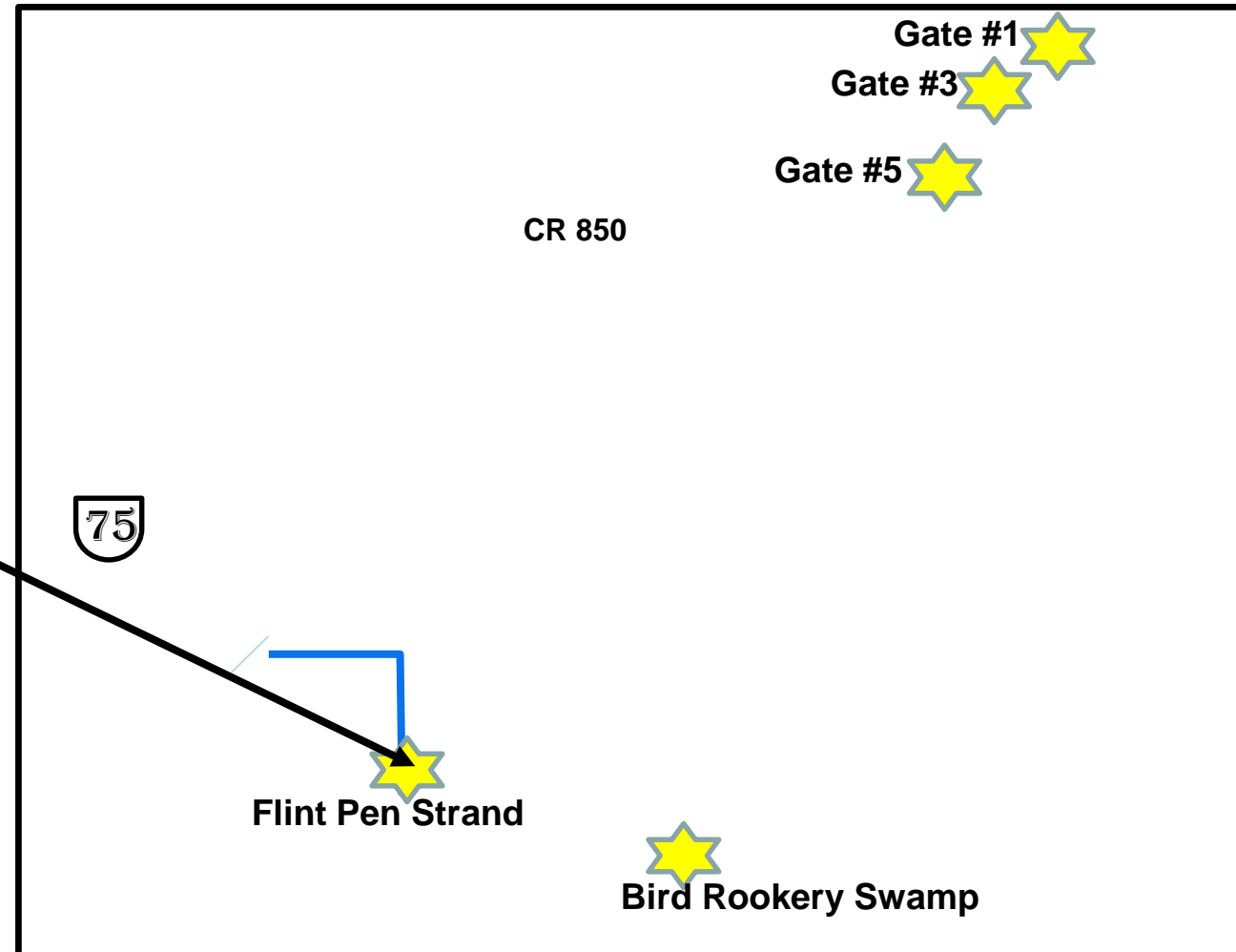
Recreational Facility Updates

New Kiosk

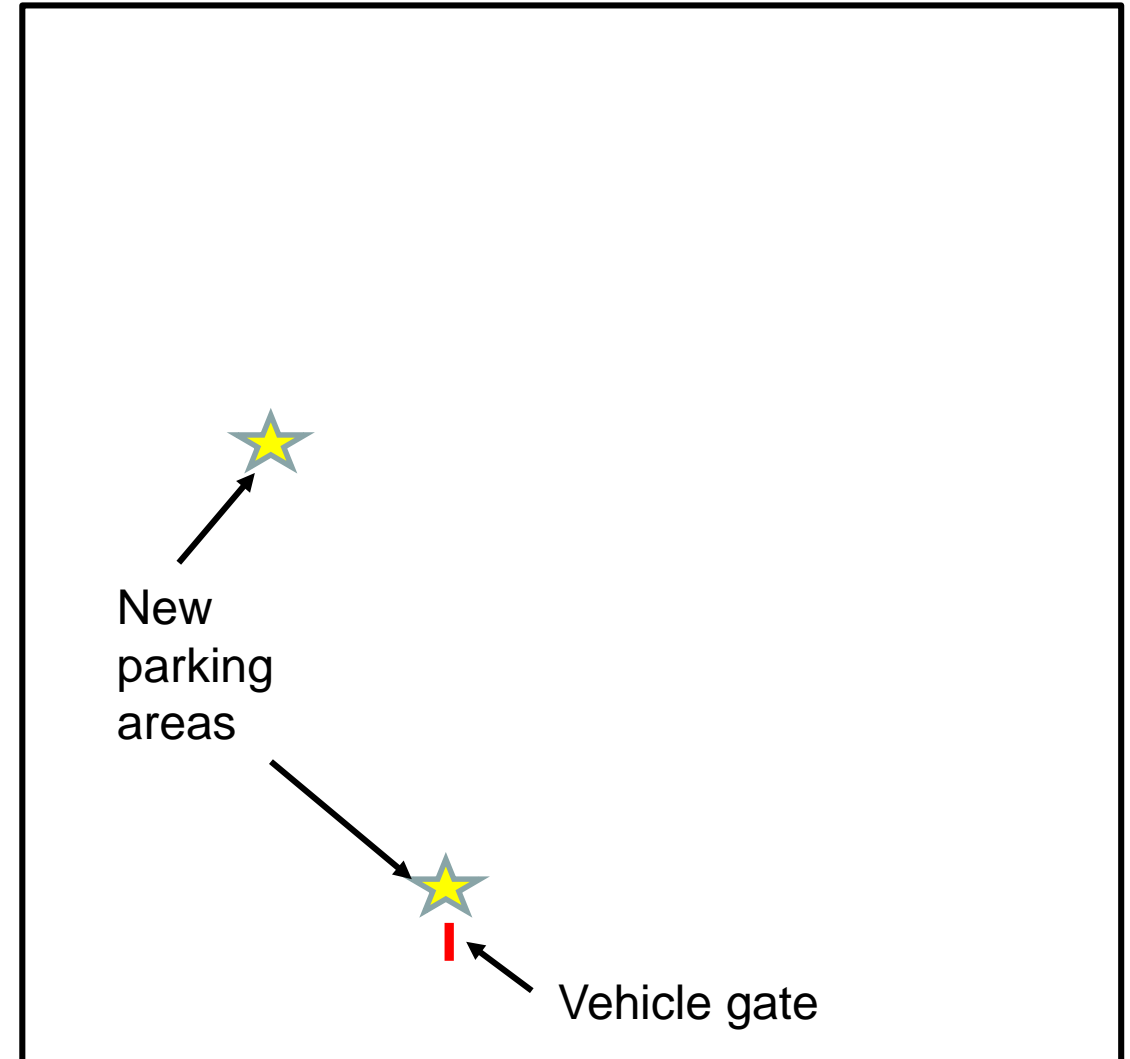

CREW Flint Pen Strand

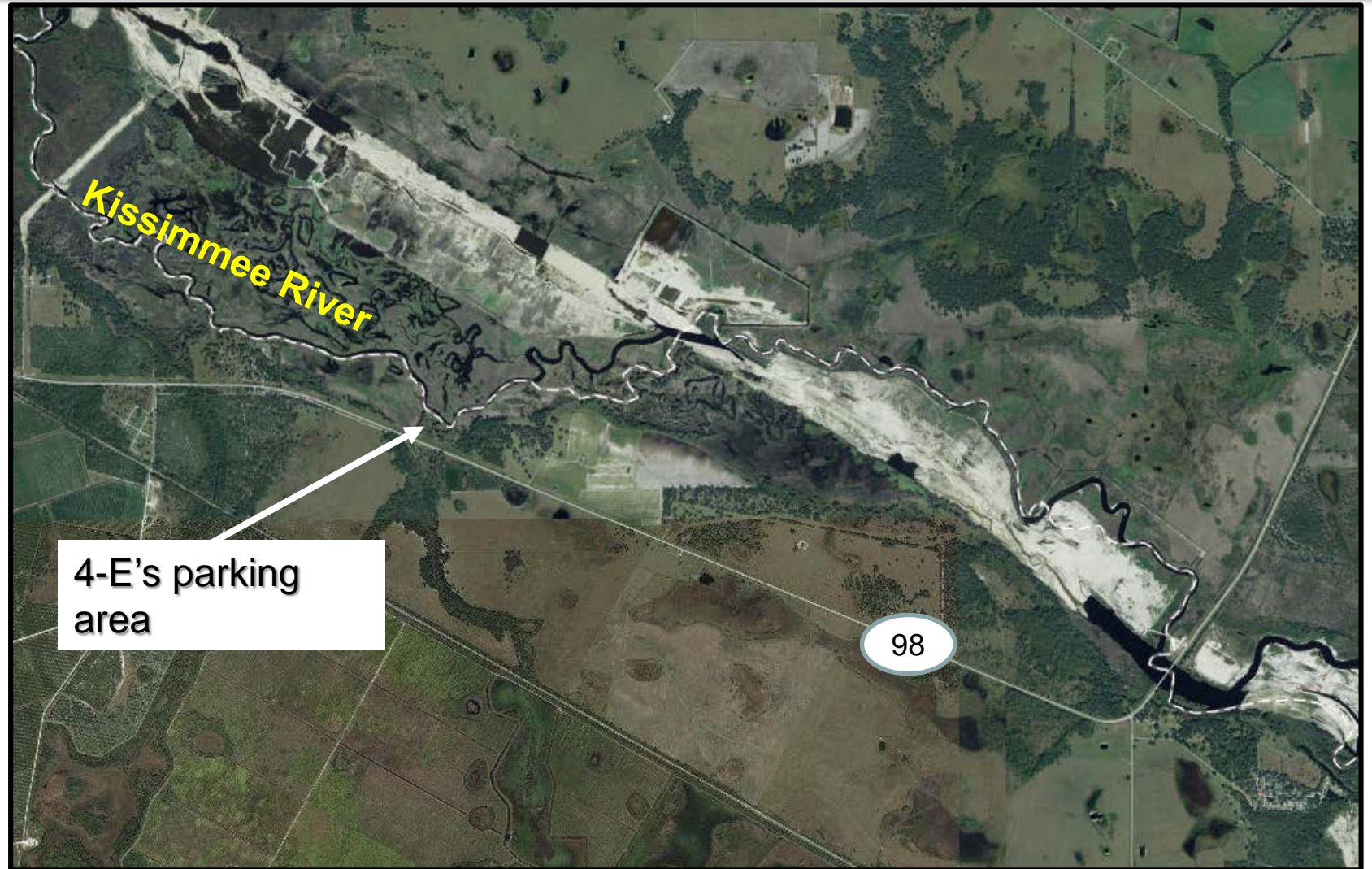
- The two additional parking areas will provide access to the eastern portion of Flint Pen Strand for recreational purposes.





Recreational Facility Updates Kissimmee River Access

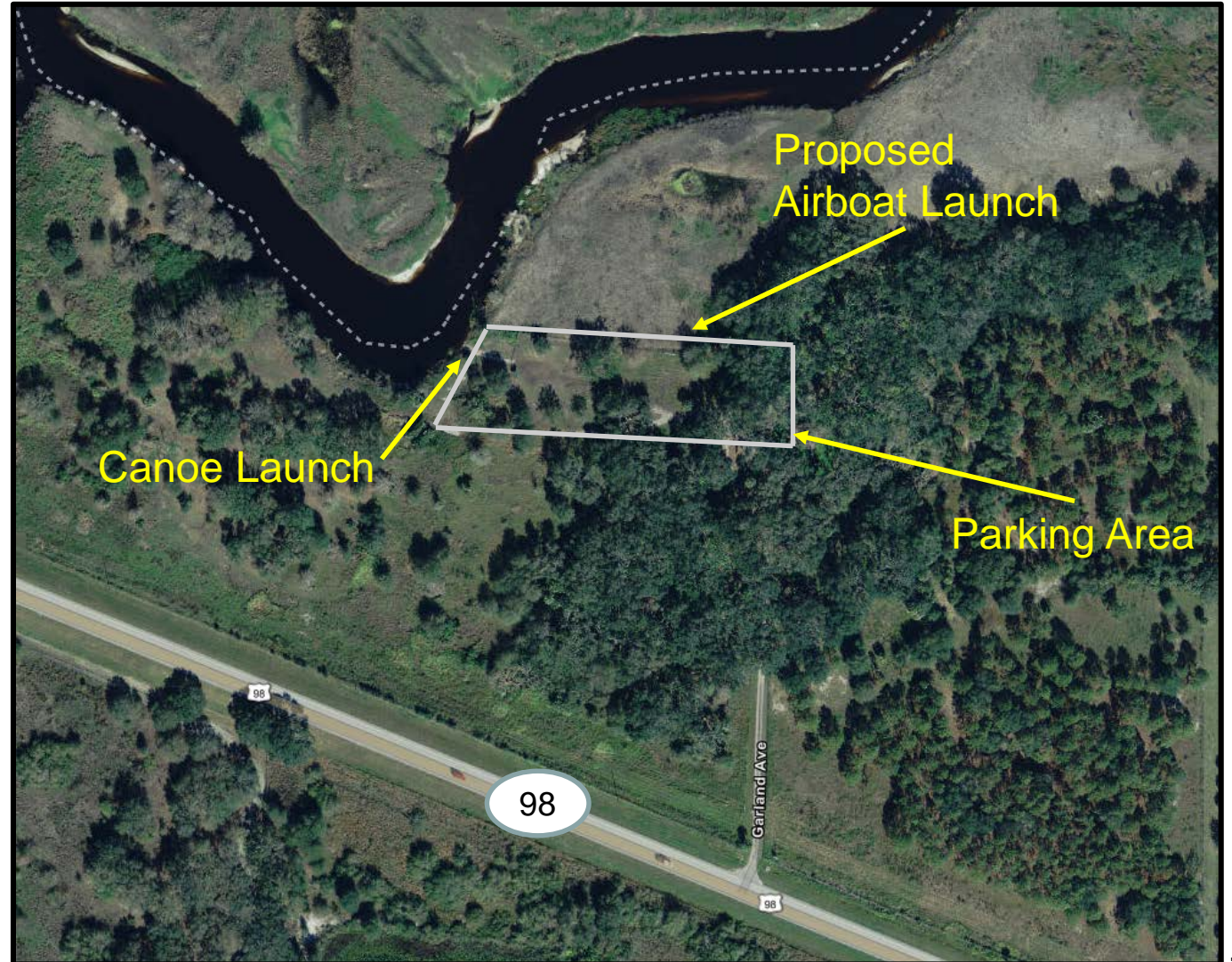
- The District's 4-E's parking area located in Highlands County off Hwy. 98 on the west side of the Kissimmee River.





Recreational Facility Updates Kissimmee River Access

- The 4-E's parking area:
 - Maintain existing canoe launch area.
 - Provide additional airboat launch area.
 - Minor improvements required including fencing removal, parking, and launch area before airboat launch is opened.





Recreational Facility Updates

Kissimmee River Access

- Additional proposed public access on the west side of the Kissimmee River, south of Hwy. 98 along 721 in Highlands County.
- Utilize an existing construction staging area from the Kissimmee River Restoration Project and replacement of the railroad bridge.





Recreational Facility Updates Kissimmee River Access

- Additional proposed public access :
- Provide parking area for public access, fishing, and potentially canoe launching.
- Minor improvements needed including clearing/mowing.
