


### **2020 Florida Forever Work Plan Amendment**


### **2020 Florida Forever Work Plan Modification**



## **2020 Florida Forever Work Plan Amendment**

- As required by statute, the Martin County Commission was officially notified of the planned project modification
- Pursuant to Section 373.139, F.S., a public hearing to be duly held on this date for the purpose of modifying the IRL-S, C-44 Reservoir and Stormwater Treatment Area project

### Resolution

A Resolution of the Governing Board of the South Florida Water Management District modifying the SFWMD Five Year (Florida Forever) Work Plan, contained in Chapter 6A, Volume II of the 2020 South Florida Environmental Report, to change the Indian River Lagoon - South, CERP Project component boundaries by moving a canal easement containing 95.33 acres, more or less, from the Allapattah Complex Natural Storage Component, and adding 108.53 acres, more or less, of non-project lands, to the C-44 Reservoir and Stormwater Treatment Area, all located in Martin County; providing an effective date.
