1. Call to Order - Chauncey Goss, Chairman

Chairman Goss called the meeting to order at approximately 5:15 PM.

2. Pledge of Allegiance

Chairman Goss led the Pledge of Allegiance.

Chairman Goss announced IT staff was on standby to assist with technical issues during the meeting and provided instructions for public comment online and by phone.

3. Public Comment on Final Millage Rates and Final Budget

There was no public comment.

4. **Resolution No. 2020 - 0930** Adopt the Final Millage Rates and certify the 2020 Tax Levy for the South Florida Water Management District (0.1103 mill), the Okeechobee Basin (0.1192 mill) of the South Florida Water Management District, and the Everglades Construction Project (0.0380 mill) within the Okeechobee Basin for Fiscal Year 2020-2021. (Staff contact, Candida Heater)

Compliance with Section 200.065(2), (e)1, Florida Statutes: Explanation of the proposed millage rate necessary to fund the Fiscal Year 2020-2021 budget.

Ms. Heater stated this was the second of two public hearings required by Chapter 200, Florida Statutes, to adopt millage rates and budget for Fiscal Year 2020-2021. Ms. Heater restated that IT staff was on standby to assist the public with technical issues during the meeting.

Ms. Heater provided a presentation on the final rolled-back millage rates for the Okeechobee Basin and the Big Cypress Basin and the final budget. Ms. Heater discussed the first substantive issue, the percentage increase in the millage rates over the rolled-back rates necessary to fund the budget, if any, and the specific purposes for which ad valorem tax revenues were being increased. Ms. Heater stated with the rates adopted by the Governing Board in July and at the September 10 Tentative Budget Public Hearing, being at the rolled back millage rates, there was no increase in ad valorem taxes to be discussed pursuant to the statute.

Ms. Heater reviewed the rolled-back millage rates and stated the final budget approval was for \$1,225,810,244.


