Good day to everyone. My name is Captain Taren Thomas Wadley a master freshwater commercial fisherwoman(A HEALTHY HARVESTER) from polk county, Fl.with generational knowledge of our freshwaters systems since the 1860's.I've spoken at many public forums on the subject of a subsidy to the public for underutilized fish populations that are not properly identified for 5 decades now.#1 I have already provided in several past meetings(not only to the water districts but also the Blue Green Algae Task Force and FWC) a graph from FWC proving that the freshwater food harvesters and bait fish harvestors, are, and have been at a level of extinction for 5 decades(the largest apex predator on the waters!!), #2 also a letter from 1972 from our FWC and current dated letters, where our FWC does not target species of low and no value (rough fish) for 5 decades,#3 our FWC has not utilized gear selective to catch these species like tilapia, brown

bullhead catfish, stunted growths of channel catfish, shad, pleckostamas, brown hoplo etc. For 5 decades #4 our FWC also has not compared their biologists ability of catch to master freshwater commercial fishermen for 5 decades, #5 I have also showed that many times our lakes and freshwater systems deemed drought levels to be our high water mark, as many of our high water marks were changed beginning in 1932 and again in the 2000's maintaining double drought levels for decades .#6 Let's not forget also the letters from our FWC beginning in 1972, of acknowledging the issues with rough fish populations, but ,simply does not know what to do with them(certainly doing nothing for 5 decades now has become detrimental and we cannot continue to ignore))I am writing these comments because, as I have been told, that speaking in these forums, I am putting the cart before the horse.Well, I feel that our Water District's, Counties, Cities, and

Blue Green Algae Task Force, FWC, ACOE, have done EXACTLY THAT, PUT THE CART BEFORE THE HORSE, by simply not recogizing the simplicity and necessaties of HEALTHY HARVESTERS FOR BOTH FISH AND PLANT BIO MASS HAND REMOVAL SUBSIDY. Just as when we had a massive Debris removal from the hurricanes, THE CITIZENS AND OUR FRESHWATER systems should be the priority, WELL BEFORE, consideration of chemical usage to poison fish like rotenine, and allum as well as our plants poisoned, or only a few companies for mechanical removal. A simple and fair subsidy on these fish and plants should be granted as well as a public workshop to best benefit the citizens and waters by putting a bounty on the products to increase independent jobs in our communities, and to improve the products \$\$ values ,that MUST BE BETTER MANANGED in our FRESHWATER systems.FISH are not considerd nor included in the assessment of pollution in

our freshwaters with proper gear with EXTREMELY SKILLED PEOPLES.I will be forwarding my various conversations, showing my attemps to have that horse first. Also a series of photos taken earlier this year, pleasenote the color of lake Banana's water prior to fishing that day (my shoe is in picture) our catch the first 2 days was over 27,000 lbs of fish and a picture of only some of the pleckostamas we did take in that day, in hopes of creating a small value for bait fish ,this lake is only 283 acres and has already been drawed down and the bottom sucked of it's muck as well as being stocked with game fish(when it already had game fish by the thousands, that i have witnessed since childhood, their overall size structure reduced until my nets would no longer catch them as they were out inhabited by invasive tilapia, plecko, brown hoplo, it has even had it's water diverted. These typs of tacticts for management are WILLFULLY WASTING **OUR HEALTHY HARVESTORS**

INDEPENDENT JOBS AND FISH AND TAXPAYERS \$\$\$.My STEWARDS??? HEALTHY HAND HARVESTING SHOULD BE THE FIRST THING CONSIDERED TO MANAGE TMDL'S THAT HAVE YET TO CONSIDERED??PRIOR to allum, rotenine, chemical spraying, drawing our lakes down to nothing and not allowing people like myself the RIGHT TO A COMPARISON OF URGENCY TO PREVENT A WASTE OF FUNDS ON ALREADY FAILED SMALLER SYSTEMS LIKE LAKE BANANA (ALL BECAUSE FISH REMOVAL WAS NOT INCLUDED). Sorry to hear about your voice. Just let me know when you are available next week. My schedule is crazy next week, there are few things I can reschedule if I need to. The sooner we can discuss your proposal the better.

Regarding the Lake Apopka program:

The SJRWMD budgets around \$800,000 a year and pays 26 cents per pound of gizzard shad removed to commercial fisherman who have received a special permit for the harvest from FWC. It's open to anyone who gets the permit, I think they said around 30 permits. I don't think we need 30 for Lake Hancock, maybe 10 or so. Another option would be to have a competitive bid process for the program, this will probably be favored by our Board. This process would allow for any commercial fisherman or group of fisherman to bid on the project and the lowest bidder would be selected to perform the project. For example, if a budget was developed using 50 cents per pound and we advertised a competitive bid process, qualified bidders would each bid their price per pound and the lowest price per pound would win the project. They are also allowed to keep marketable species such as tilapia and catfish, however they aren't paid the bounty for those fish. The Apopka program is specific to gizzard shad, but I dont see why this couldnt be expanded to cover additional species of rough fish, they would just need to be identified as a target. The District then hires a contractor to construct a temporary facility near one of the boat launches to weigh the catches and issue checks to the fisherman. When all the budgeted funds have been distributed the harvest is over. Fisherman are responsible for hauling off the harvest of rough fish to a landfill or if they can find a market for them they can sell them. My thinking is that our District would have to structure a similar program, as we do not have the equipment or staff to man such a facility, so we would have to contract that part out. We can discuss the specifics of the program, open to hearing any ideas you may have. What I really need from you is an overall budget, price per pound, target species list, and ultimately the pounds of fish that will be removed which we can calculate based on the budget and price per pound. The Board is going to want to have some idea of what improvements will occur in the Lake from the expenditure. It's easy to calculate the nutrients removed by the pounds of fish removed, forecasting nutrient concentration reductions or chlorophyll reductions is not. If a sufficient number of fish are not removed, nutrient and chlorophyll concentrations are unlikely to change. Literature says approximately 70% reduction is needed for water quality improvements (a google search for rough fish harvesting/biomanipulation will provide a good number of past research projects specific to shallow subtropical lakes). When working your numbers for the proposal, keep in mind if the governing board ultimately funds a project, it will be for one year, additional years would be considered if the Lake responds (reduction in nutrient and chlorophyll concentration). There is sufficient WQ data collected in the Lake to capture the improvements. You don't have to use the 70% removal number if you don't think that is accurate based on your knowledge of the systems, but I would target a percentage you believe will produce reductions in nutrient and chlorophyll concentrations in the Lake. The Board will ask for the water quality data pre and post harvest and will use this information to guide future funding for this effort.

Look forward to talking with you next week. Let me know your availability as soon as you can and I will see how I can fit it into my schedule.

Hello Taren,

We had our internal meeting to discuss haul seines in the northeast region on Monday. Several things have come out of that discussion.

First, the use of haul seines on Lake Toho is not going to be considered at all for a number of reasons.

With regards to Lakes Apopka and Jessup, I will be researching and discussing with stakeholders the potential for haul seine operations. On Apopka, I will be talking with the water management district to determine if they have any issues with allowing haul seine operations. I will be discussing the issue of haul seines on Jessup with local stakeholders as well.

If we decide to allow haul seining on either lake it will be done as experimental permits. It will not be limited to one haul seiner. A small number of permits will be available, and depending on the interest from commercial anglers, if more anglers apply for the permits than are available, they will be awarded randomly and the angler will have to then show they can meet all the requirements with gear. The permits will not allow for haul seining near shore or near vegetation (similar to the experimental permit we issued you back in the fall last year for shad harvest on Apopka). The permit will require that all gamefish be released alive immediately. The permit will require that all gizzard shad captured must be harvested along with any hoplos and armored catfish (and of course tilapia). There will be no subsidies granted for any fish harvested. If allowed on Jessup, haul seining will not be allowed during the American

shad run. Haul seine anglers will also be required to provide GPS coordinates for where they fished and call in to our regional dispatch to inform them of time and location when they are going to fish.

There are a number of details to refine and smooth out if we decide to go this direction, and as I mentioned, we will be gathering stakeholder input first. I say tis to let you know that a decision will not happen over night and it will take some time to make a final decision on the matter.

In my previous email, I am basically or now requesting gear comparisons as i believe a haul seine should be utilized in collecting many species of fish .I would like to have an opportunity to prove how dominating fish populations can be utilized to improve the freshwater commercial industry. In the Kissimmee chain, I can, (if comparisons are ageed to be done to identify best catching gear along with best skilled WILDCATCH fishermen to that of ffwcc biologists ability to catch ), prove with an opportunity to pull a haul seine, that bream can and should be utilized for commercial harvest and anglers cannot match the harvests for any type of management, which to date has only led to fish resources to be completely underutilized. Im sure if i AM GIVEN OPPORTUNITY I can catch 30,000 lbs of bream in 3 different ares of lk Kissimmee, only covering 40 acres at a time, it would be safe to say that you could not put 600 sports fishermen per haul to maintain prevention of underharvesting. Data collected from gear that can be proven it is not selective to catch, but then data is still recorded as if it the gospel by FFWCC, which brings to question the integrity of FFWCC to the industry ?Also, when you came to lake Apopka when i pulled a trial run with my seine, my soul goal was to prove my nets authenticity of its ability to fish shallow muddy lakes like i currently fish., therfore you did not get any type of true representation of any schools of fish, so considering you will be regulating me on lks Apopka and Griffen i feel that beings you, Or anyone in ffwcc knows nothing about my skill of catch with a haul seine, should be best observed by you and Eric on a physical experience. As far as social distance, I have plenty of boats that it will be accomadated in.I am bringing these issues to you and Eric and have full intentions to bring it to the Govenor's attention. My industry deserves for FFWCC to save it not KILL it thru neglect of knowledge intentionally. I have the skill and knowledge of catch of many species far above FFWCC and though it's findings may hurt due to truth by catch of volume and skill, wellIll.....the truth hurts!!
