






Project Overview

- Goal: Restore ecological integrity to the Kissimmee River and its floodplain
- 50/50 Cost-share State/Federal
 - SFWMD: Land acquisition and environmental monitoring
 - USACE: Design and construction
- Backfill 22 miles of C-38 canal
- Restore flow to 40 miles of river channel
- Remove 2 water control structures
- Mimic historic inflows
- Restoration Evaluation Program
 - Evaluate project success




Next Steps

- Complete remaining construction
 - S-69 weir and backfill repair ~ May 2021
 - Reach 2 ~ May 2021
 - Berm cuts at US-98 culverts and ditch plug/berm cuts at Reach 3, Spoil Area D
 ~ May 2021
- Implement revised regulation schedule
- Restoration evaluation monitoring following Headwaters Revitalization Schedule implementation
