This is consistent with the previously provided historic aerials that show the system excavated from uplands sometime in the late 1970's/early 1980's.

As far as survey data, I checked our files and also checked with DWMA. We don't have on-ground spot elevations around this cut. However, the engineering plans submitted to the District with this project, and past sequences, utilize Osceola County's 2016 Lidar...which has been accepted for use by SFWMD. I've attached a copy of the lidar with the SFWMD's FWD approved limits overlaid.
